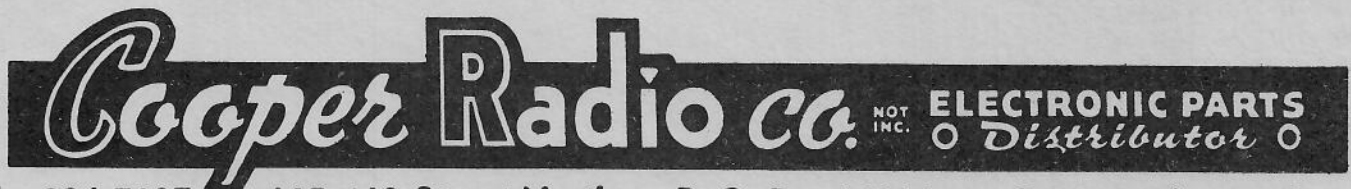

The Treasurer's Report was given by Frank Ryll W4VIP. It was approved as read.

The minutes of the last meeting were read and approved.

The meeting was recessed at 8:45 p.m. for coffee and doughnuts, and was called back to order at 9:03 p.m.

Jack Gordon W4MIM told about using a TV set to pick up tornado sightings as far as 10 miles away.

The Metro Amateur Radio Club will coordinate Field Day this year. Field Day will be held the last weekend in June, and will take place at CD Headquarters.

Rex Cottrell W4GPL called the Mayor's office to invite her to a meeting and to receive an Honorary Member certificate, but was told that she was booked solid for the next-four months. He will try again at a later date.

OFFICIAL BULLETIN NR 703 FROM ARRL HEADQUARTERS
NEWINGTON CT APRIL 13, 1978 TO ALL RADIO AMATEURS BT

The deadline for filing petitions for reconsideration in Dockets 21116 and 21117 is April 26, 1978. These FCC dockets would prohibit the marketing of external radio frequency amplifiers capable of operation on any frequency between 24 and 35 MHz, and would bring all amplifiers capable of operation below 144 MHz under the control of the Commissions type acceptance program. The text of these dockets may be found in the March 27, 1978 edition of the Federal Register, available at your local library. Petitions for reconsideration may be sent to the Secretary, FCC, Washington, DC 20554. AR

OFFICIAL BULLETIN NR 706 FROM ARRL HEADQUARTERS
NEWINGTON CONN MAY 4, 1978 TO ALL RADIO AMATEURS BT

During the summer travel season many amateurs visit ARRL Headquarters and W1AW. The league headquarters office building is open to visitors from Monday through Friday from eight AM to five PM EDT without appointment. Visits other than during these hours can be arranged by writing ahead to ARRL. The Maxim Memorial Station W1AW is open for visitors during additional hours as announced in QST. Both the Headquarters building and W1AW will be closed on May 29, July 4 and September 4. Printed directions to ARRL are available for a self addressed and stamped envelope with thirteen cents postage to ARRL, 225 Main Street, Newington CT 06111. If you plan to operate from W1AW remember to bring your original license, not a photocopy. AR

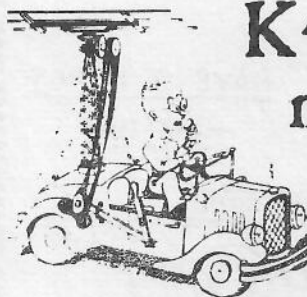

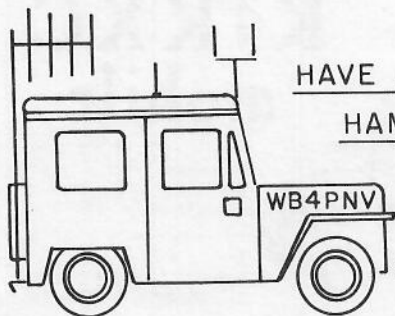

Congratulations to 77 year old Arthur Shaw, AA4BI. Arthur was first licensed in 1916 with amateur call 1AEQ. OFFICIAL BULLETIN NR 704 FROM ARRL HEADQUARTERS ---
NEWINGTON CT APRIL 20, 1978 TO ALL RADIO AMATEURS BT

In a special revision released on April 5, 1978 the FCC reminded American Amateur radio operators of the restraints on international third party communications. The United States now has third party agreements with Argentina, Bolivia, Brazil, Canada, Chile, Colombia, Costa Rica, Cuba, Dominican Republic, Ecuador, El Salvador, Ghana, Guatemala, Guyana, Haiti, Honduras, Israel, Jamaica, Jordan, Liberia, Mexico, Nicaragua, Panama, Paraguay, Peru, Trinidad & Tobago, Uruguay and Venezuela. A special agreement with the ITU permits certain third party communications with 4U1ITU. The Commission further reminded U.S. Amateurs that transmission or delivery of international third party messages is prohibited unless an agreement under Section 2 of Article 41 of the ITU Radio Regulations has been announced by FCC. For a half wave stub shorted at the far end substitute "492" in place of "246" and calculate in the same manner. The Velocity Factor (k) is approximately:

0.83 for 300 ohm twin lead; 0.77 for 150 ohm twin lead; 0.69 for 75 ohm twin lead;
0.67 for solid dielectric coaxial cable.

The physical and electrical length may vary, depending upon the material used for the stub, and for this reason "pruning" may be necessary. In the case of a half wave shorted stub using twin lead, a piece of tinfoil may be wrapped around the line and this shorting device moved until the interference disappears. Careful pruning with a pair of cutting pliers will serve the same purpose.

- (c) Interference due solely to inability of a receiver using 21 Mc i.f. to reject 21 Mc band fundamental frequency transmissions can usually be remedied by having a serviceman realign the i.f. circuits of the TV receiver to a slightly higher frequency.
- (d) A pair of correctly spaced Lecher wires, set up to an appropriate length and calibrated to include receiver i.f. and television channels will materially aid in determining the frequency, or combination of frequencies, causing the interference.
- (e) Aside from the immediate problem of interference believed to be caused by an Amateur station, experience has shown that installation of a high-pass filter will often improve reception in general by reducing the probability of future interference from other sources.

The Commission trusts that the foregoing information will be of help to you in clearing any reports of neighborhood television interference brought to your attention, and would appreciate receiving information from you as to steps you may take toward eliminating or reducing the interference caused by operation of your amateur station, indicating the particular device that was most effective.

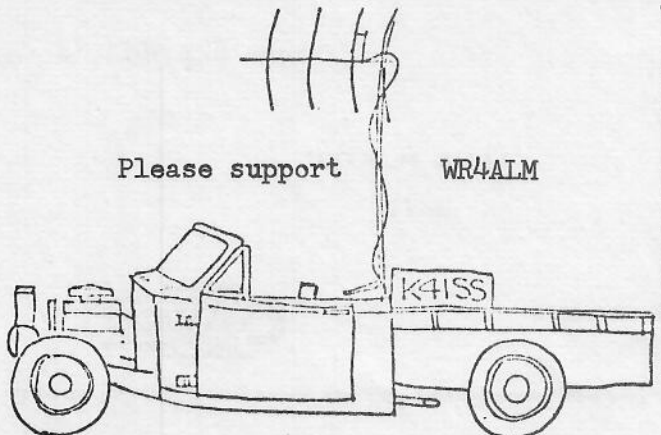

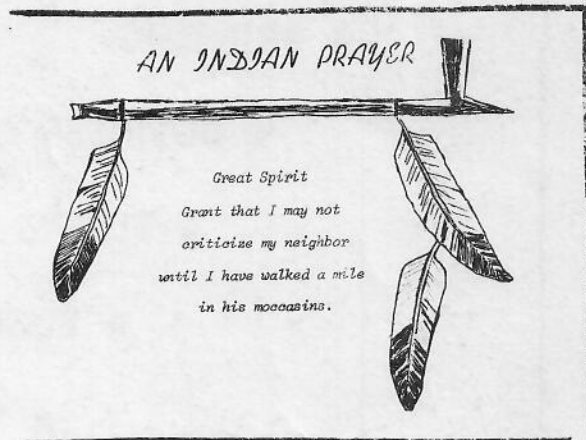
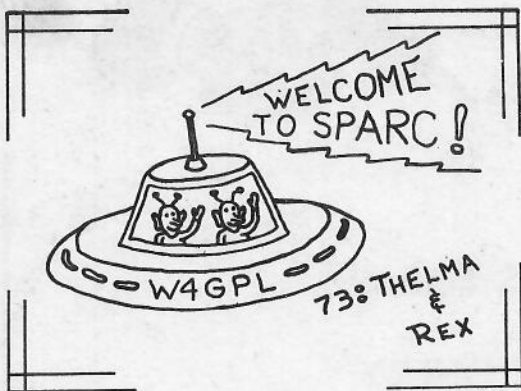
