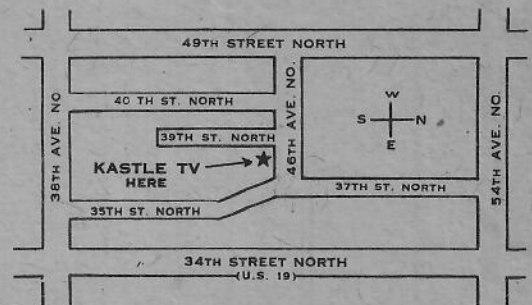

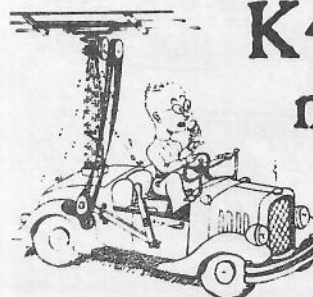

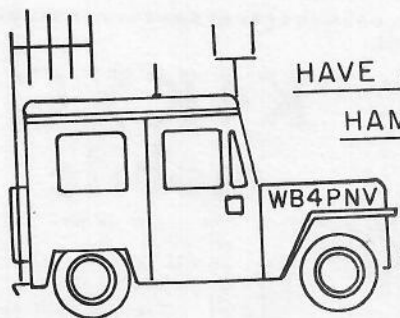

Our congratulations to the new officers elected at our Dec. 1st meeting.

With the recent Jonestown debauchery highlighting exploitation of Amateur Radio for illegal purposes, it behooves us all to take care and be on the alert. We suspect that Amateur bands have been used by illegal drug traffickers, various criminal activities, business communications of both non-profit and profit-making organizations, including strange "religious" cults. We must do our best to prevent this from taking place -- especially on the SPARC Repeater. With our autopatch scheduled to go on the air soon, our care and supervision must be intensified.

For those members who want to use the autopatch for legitimate purposes, procedures are reviewed here. Learn them well. Steps in autopatch use:

1. Ensure repeater is clear -- no conversation in progress. Conversations in progress have priority.
2. State your intention: "K4SCL to use autopatch."
3. Punch in the autopatch access code. This code is to be divulged to members only.
4. Listen briefly for dial tone confirming you are on autopatch.
5. Punch in the number you are calling.
6. While waiting for number to ring and answer, state your call-sign and number called: "K4SCL calling 584 0984."
7. When party answers, advise him you are calling via amateur radio autopatch, giving sufficient detail to warn the party that whatever he says may be heard by others besides yourself and that bad language is not acceptable. Make this as brief as possible, using your good judgement as to what is necessary based on your knowledge of the person called.
8. Complete the conversation briefly.
9. State time clearing autopatch: "K4SCL clearing autopatch at 9:53." Approximate is OK. This helps us determine time of events recorded.
10. Punch autopatch disconnect code.
11. Clear with repeater: "WR4ALM this is K4SCL clear."

FCC to Consider Exam Changes

The Federal Communications Commission (FCC) has opened an inquiry into the administration of telegraphy (international Morse code) examinations to handicapped applicants for operator licenses in the Amateur Radio Service.

The FCC needs comments to find out if its current policies and rules towards the administration of amateur telegraphy examinations to the handicapped should be changed. Comments should consider the following possible alternatives for FCC action:

- Maintain the *status quo*.
- Adopt a rule to lower the telegraphy speed for handicapped applicants.
- Create a "codeless" license for the handicapped and limit operation to frequencies above 144 MHz.
- Waive the rules to lower the code speed for the handicapped.

Comments are due no later than November 30, and should be addressed to the Secretary, FCC, 1919 M. Street, N.W., Washington, D.C. 20554.

All comments should contain the correct Docket Number of this Inquiry, which is SS Docket 78-250. Further information concerning this Inquiry may be obtained from Gregory M. Jones, Safety and Special Radio Services Bureau, (202) 632-7510. The deaf or hearing impaired may obtain additional information about this Inquiry by calling the FCC's attended TTY at (202) 632-6999.



OFFICIAL BULLETIN NR 730 FROM ARRL HEADQUARTERS NEWINGTON CT OCTOBER 26, 1978 TO ALL RADIO AMATEURS BT

The Governments of the United States and Surinam consummated an Amateur Radio reciprocal operating agreement with an exchange of diplomatic notes on October 12, 1978. The agreement is effective that date, so amateurs of either country desiring to operate in the other can do so upon application to proper authorities. OFFICIAL BULLETIN NR 728 FROM ARRL HEADQUARTERS NEWINGTON CT OCTOBER 12, 1978 TO ALL RADIO AMATEURS BT

During a meeting held Thursday October 12, and widely publicized in advance as Personal Radio Day at FCC, the Commission directed its staff to prepare a Notice of Inquiry for a new Personal Radio Service to operate on 900 MHz. This decision was based on recommendations of the Safety and Special Radio Services Bureau that 900 MHz was preferable to other frequencies for this proposed service for the following reasons. 1. Better chance of coordination with Canada and Mexico. 2. Less television interference. 3. No present users who would be displaced. 4. Less expensive for FCC to administer. 5. More spectrum would be available. Further information will be released as it becomes available, by bulletin from this station and later in QST. AR

OFFICIAL BULLETIN NR 735 FROM ARRL HEADQUARTERS
NEWINGTON CT DECEMBER 7, 1978 TO ALL RADIO AMATEURS BT

FCC has proposed protecting its monitoring stations at Allegan, MI, Anchorage, AK, Belfast, ME, Douglas, AZ, Ferndale, WA, Fort Lauderdale, FL, Grand Island, NE, Kingsville, TX, Laurel, MD, Livermore, CA, Powder Springs, GA, Sabana Seca, PR and Waipahu, HI from harmful interference. Amateurs who run a kilowatt within 10 miles of one of these locations could be affected. The deadline for comments in General Docket 78-365 is January 22, 1979. Amateurs may request a copy of this NPRM by sending a large stamped self-addressed envelope to ARRL, 225 Main Street, Newington, CT 06111. In other action, the Commission extended the comment deadline for General Docket 78-250, regarding code examinations for the handicapped, until March 30, 1979. AR

OFFICIAL BULLETIN NR 729 FROM ARRL HEADQUARTERS
NEWINGTON CT OCTOBER 19, 1978 TO ALL RADIO AMATEURS BT

During a meeting held Thursday, October 19, 1978, the FCC formally adopted an interpretation of Section 97.79(d) of the Amateur Rules as it applies to autopatch. The Commission declared that autopatch over an automatically controlled repeater is not allowed. Any autopatch must be monitored by a repeater control operator. The FCC also directed its staff to send ARRL a letter indicating this interpretation. Further information will appear in QST. AR

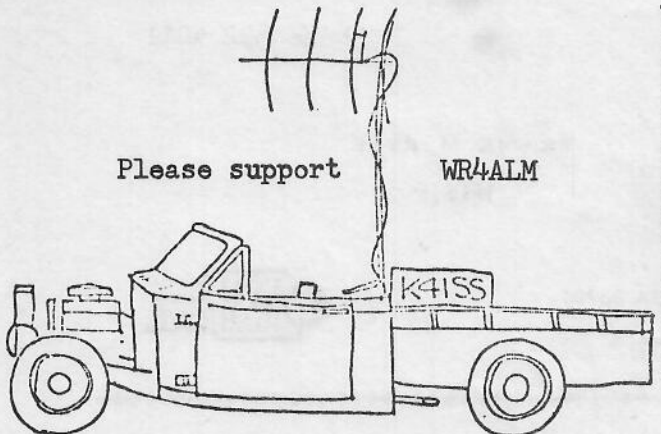

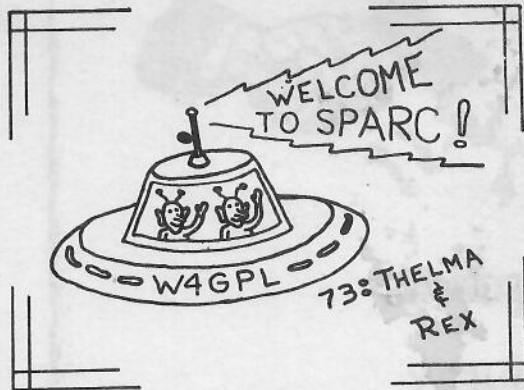
